

The Taxable Wage Base for 2021 has increased to \$32,400. To verify the information, either key in the Tax ID or search for the ID in the Taxes option. On the Tax Table tab, enter 2021 in the Tax Year. The Tax Rate will reflect the value from the previous year and should be edited to be the appropriate figure if necessary. The Limit has already been updated to reflect the new taxable wage base of 32,400.00. Below is a screen image of the 2021 limit information. ## 2021 Iowa Retirement (IPERS) Limit

The IPERS Upper Limit for 2021 has increased to \$290,000. To make this change, either key in the Deduction ID or search for the ID in the Deductions option.
