The Taxable Wage Base for 2023 has increased to \$40,800. To verify the information, either key in the Tax ID or search for the ID in the Taxes option. On the Tax Table tab, enter 2023 in the Tax Year. When prompted to copy the previous year tax table, select **Yes**. The Tax Rate and Limit will reflect the values from the previous year and should be edited to be the appropriate figures if necessary.
